Subject: Regarding "pending scholarship under Post Matric Scholarship (Scheduled Caste and Backward Classes) for the session 2018-19 and 2019-20.

In reference to your memo no. 230 dated 13.01.2025 on the subject cited above.

In this regard, the following is submitted as under:-


1. The scholarship under Post Matric Scholarship is provided to the students belonging to Scheduled Caste and Backward Classes category who are studying/ have studied in the course under the purview of Technical Education and whose annual family income from all the sources does not exceed Rs. 2.5 Lakh.
2. The scholarship against most of the applications under Post Matric Scholarship for the session 2018-19 and 2019-20 has been disbursed, but, some of the applications are pending for approval/ disbursement due to some document deficiency.
3. The Disbursing Centre for Post Matric Scholarship i.e. Govt. Polytechnic, Nilokheri (Karnal) has made numerous efforts to clear the pendency through E-mails/ letters. Despite of several reminders/ efforts, only a few students have removed their document/ bank issue deficiency in the last 1.5 years and rest of the institutes/ students are not responding.
4. The above matter was apprise to the competent authority and it was decided that a last opportunity of 40 days from 21.04.2025 to 30.05.2025 is hereby given to the concerned institute/ students to clear the pendency. After this given time span, the remaining pending applications at institute /students level will be treated as rejected and concerned institute/ students will be responsible for the same and no more communications/ requests for more chance/ opportunity will be entertained by the department, as more than sufficient time and a number of opportunities have already been given.

Keeping in view of the above, such institute/ students is hereby informed that they can visit the scholarship cell GBN Govt. Polytechnic, Nilokheri District Karnal, Haryana during office hours from 9:00 AM to 5:00 PM on any working day between 21.04.2025 and 30.05.2025 alongwith the following documents:-

- i) Approval letter of the institute from AICTE/PCI/Council of Architecture (as applicable according to the course) for the session 2018-19/ 2019-20.
- ii) Fee structure approval by State Fee Committee/Fee Rationalization Committee for the session 2018-19/2019-20.
- iii) Receipt /certificate regarding fees paid to institute for the session 2018-19/2019-20).

- iv) Aadhar Card.
- v) Caste Certificate.
- vi) Haryana Residence Certificate.
- vii) Family income certificate for the session 2018-19/2019-20.
- viii) Outside Proforma for attendance proof for 2018-19 verified by Head of Institute (for students studied in institutes located outside Haryana).
- ix) Degree/Diploma and Detailed Mark-sheet Certificates.

It is also informed that no more communications/requests for more chance/opportunity will be entertained by the department for any pending application under Post Matric Scholarship Scheme for the academic session 2018-19 & 2019-20 after 30.05.2025.
