Report of the Inspection Committee that visited DPG Institute Of Technology & Management, Gurugram with regard to continuation/extension in provisional affiliation of BBA and BCA w.e.f. 2024-25.

The inspection committee comprising Dr. Preeti Gulia, Dr. Seema, Dr. Meenakshi Hooda, Dr. Priyanka Yadav visited **DPG Institute of Technology & Management, Gurugram** on 24.07.2024 for considering proposal for continuation of BBA and BCA with an intake of 240 and 320 respectively w.e.f. 2024-25.

Observations of the committee:

The inspection committee physically verified the available faculty, infrastructural facilities viz. building, computer lab, staff, library, class-rooms, furniture, etc. for above proposals and makes the following observations:

1. The College has been established in 2011 and is run under Chaudhary Harnarain Singh Educational Cultural and Charitable Trust affiliated to M.D. University, Rohtak. There are various courses offered by the college under the SFS scheme.
2. Compliance: The previous Inspection was done on 15.06.2023 and the University has granted the approval to these courses. The college has admitted to appoint 12 faculty members and 4 non-teaching staff vide letter No. DPGITM/471 dated 14.12.2023.
3. AICTE Approval: The College got the EoA for the Academic Year 2024-25 from AICTE for various courses and have taken the first time approval for BBA(240 seats) and BCA(320 seats).
4. Governing Body: The College has duly constituted its Governing Body and there is a University Nominee also in the same as per the University norms.
5. Land and Infrastructure Details: The College has land of 2.5 acres. The college building has 6 Classrooms for BBA and 19 Classrooms for BCA. It has 3 Tutorial Rooms each for BBA and BCA programs. There are 4 Computer Laboratories for the BCA program with 180 computers and 6 printers. The Administrative area (Principal/Director office, Office, Cabin for HOD, Staff room. Other amenities like playground, separate Common Rooms for Boys and Girls, Hostel, safe drinking water and toilets for Male and Female are adequately available.
6. Teaching & Non-teaching Staff: There are only 14 Assistant Professors for BBA and 15 Assistant Professors BCA program. However, there are only 5 faculty members who are approved for CSE course. There are no University approved teaching staff in BBA as well as BCA program. The college has appointed 1 Librarian, 1 Technical Assistants, 1 Office Assistant-cum-Accountant/Clerk-cum-Typist/Data Entry Operators, 1 Lab Attendants, 1 Safai Karamchari and 1 Peons for BBA program. Similarly, there are 2 Technical Assistants, 1 Office Assistant-cum-Accountant/Clerk-cum-Typist/Data Entry Operators, 1 Lab Attendants, 1 Safai Karamchari and 1 Peons for BCA program. The members of the committee interacted with the teaching and non-teaching staff present during the visit of the college.

It is submitted that the college is required to maintain the number and cadre ratio of their Teaching Staff and the Administrative and Support Staff as per the number of units of Intake of each course. Moreover, it is advised to ensure that college takes appropriate steps for the University approvals of the faculty members and Non-teaching staff in appropriate numbers.

7. Library: The College has a common Library with the capacity of the Reading Hall to accommodate appropriate seating capacity. It has 300 titles and 3120 volumes for BBA program & 322 titles and 3220 volumes for BCA program. It has subscribed to 18 Journals for BBA and 07 IT magazines for BCA. It has also got subscribed an adequate number of National/International Journals related to Computer Science/IT and Newspapers.

It is advised to subscribe for adequate number of books and titles for both BBA and BCA programs as per the units of intake.

8. Computing Facilities and Licensed Software: The College has deployed 140 computers for BBA and 180 computers for BCA courses with 9 and 6 printers respectively. There are 2 System software and 10 Application Software. The labs have adequate power backup facility.

9. Internet Bandwidth & WiFi: The College has adequate Internet bandwidth of min. 32 Mbps to cater all internet related tasks.

10. Audio-Visual Aids: There are 4 Audio-Visual aids (Classrooms and Seminar Halls) for teaching and learning in BCA program. Online resources from SWAYAM/NPTEL/MOOCs/Others are also maintained by the college.


12. Mandatory Disclosures: The College is required to comply to all the mandatory disclosures as issued by AICTE/University from time to time along with any other regulatory authority as per the norms.


Recommendations


In view of the above observations, the committee recommends that DPG Institute of Technology & Management, Gurugram may be granted:


1. Extension/Continuation in Provisional Affiliation for BBA with an intake of 240 seats (3 units) w.e.f. the session 2024-25.
2. Extension/Continuation in Provisional Affiliation for BCA with an intake of 320 seats (4 units) w.e.f. the session 2024-25.

The points related to the number of faculty members along with the cadre ratio and university approvals as per the number of units should be made by the Institute. University approval and number of Administrative and Supporting staff should also be made as per the number of units of intake of the above mentioned courses. The number of computers for BCA should be increased in proportion to the intake of the course.
