NOTIFICATION

(Special/Mercy Chance)

In continuation of this office Notification No. MDU/R-1/AE-5/2026/14709-14808 dated 22.04.2026 and subsequently, Notification No. MDU/R-1/AE-5/2026/16350-16455 dated 09.06.2026, it is notified for information of all concerned that the last date, for submission of online Examination Form for Special/Mercy chance as per Notification available at University Website www.mdu.ac.in, is further **extended upto 06.07.2026** which was earlier 20.06.2026.

The other conditions as contained in Notification No. MDU/R-1/AE-5/2026/14709-14808 dated 22.04.2026 shall remain unchanged.

1. The students who got registered/enrolled themselves for their particular program in the year 2001 onwards shall only be eligible for this special chance. However, As per Academic Council Resolution No. 56 dated. 10.09.2021, the Standing Committee constituted by the Vice-Chancellor may consider requests for granting special chance on case to case basis, irrespective of year of registration and may recommend the cases to the Vice-Chancellor for approval.
2. The examination for special/Mercy chance shall be held in offline mode only at the premises of University Campus.
3. The examination for Mercy chance may tentatively be conducted in the month of **August 2026**.
4. The online portal/panel for Mercy Chance shall be opened upto **06.07.2026**.
5. For this special chance, Exam wise/Course wise fee shall be chargeable as under:-

6. The examination forms and fee shall be filled up through online mode as notified by the University. The students are advised that before submission of online examination form and fee, they must check/ensure their eligibility, and in case of any doubt, they must confirm it from the concerned Result Branch. If any "INELIGIBLE STUDENT/CANDIDATE" submits his/her examination form and fee without ensuring his/her eligibility, then he/she will be solely responsible for the same and the examination fee deposited by him/her will not be refunded by the University in any case. All the students desirous of availing this chance are advised to read the following conditions/instructions carefully:-

- The schedule of examination/declaration of result will be notified depending on administrative requirement of the University and students will have no claim for early conduct of examination as well as declaration of result.
- The special chance is admissible to complete the Degree (course) for such students who have re-appear in one or more papers (subjects) and also for improvement of division, who could not improve division within their admissible chances. However, improvement is not permissible for B.Ed. program.
- The special chance will also be admissible for the students of PG Programmes for improvement of their marks from less than 50% to 55% or above.

- iv) For those students who were originally enrolled during/after 2001, they will have to take their exam(s) as per the scheme of examination/syllabi applicable in their respective year of registration.
7. The candidates enrolled/registered prior to 2001 and recommended special chance by the Standing Committee shall be allowed subject to the following:-
- The scheme and syllabi of examinations will remain the same as that was prescribed in 2001 for all the candidates registered before 2001 and they shall not claim for any nomenclature/syllabus according to their year of registration.
 - All such students under the special chance shall appear for exam at their own risk subject to the availability of nomenclature matching with the prescribed syllabus in 2001. If any dispute remains there in this behalf, the committee will decide this after the examinations, if required.
 - All such candidates shall not claim for nomenclature/syllabus according to their registration year and to this effect, they will also be required to submit an undertaking at the time of filling exam forms.
